Recall Description

General Motors has decided that certain 2010-2012 model year Chevrolet Colorado and GMC Canyon vehicles fail to conform to Federal/Canada Motor Vehicle Safety Standard 113, requiring a secondary hood latch. These vehicles may have been assembled with a hood that was missing the secondary hood latch.

Remedy

Dealers are to inspect for the presence of the secondary hood latch. If the latch is missing, dealers are to replace the hood. Because this

inspection can easily be performed by the customer, and to reduce their inconvenience, an inspection procedure will be mailed to customers. If, however, the customer is uncomfortable performing the inspection, they will be instructed to contact their dealer for the inspection.
